

Nonexclusive Licence Agreement No.

Hereinafter the "Licensor"

and

University of Warsaw [*Uniwersytet Warszawski*], ul. Krakowskie Przedmieście 26/28, 00-927 Warszawa, NIP [VAT ID] 525-001-12-66, hereinafter the "Licensee", represented by dr Dorota Celińska-Janowicz, Secretary of the Editorial Board of *Studia Regionalne i Lokalne* quarterly.

§1

1. The object of this Agreement is the granting of the license to use the paper entitled

..... hereinafter the "Work".

2. The Licensor delivers the copies of the Work to the Licensee in the form of an electronic file.

§2

1. The Licensor warrants and assures that she is the author of the Work and that the Work does not infringe upon third parties' rights. The Work was prepared while respecting the copyrights of other authors.

2. The Licensor warrants and assures that she holds the author's economic rights to the Work.

3. The use of the work by the Licensee shall not infringe upon third parties' rights.

§3

1. The Licensor grants the Licensee the consent to use the Work within the following fields of exploitation:

- a) Free-of-charge publication of the Work in *Studia Regionalne i Lokalne* quarterly by the University of Warsaw;
- b) Placing, maintaining and processing the Work on magnetic information carriers;
- c) Dissemination of the Work, free of charge or for a fee, in the form of an electronic file, in full or in parts, as a separate work or in structured bases or collections, on an Internet website and in printed form, and making the Work available to the public in a way that permits access to all interested parties in the location and at the time at their discretion;
- d) Using excerpts of the Work for advertising or promotion purposes, with no restrictions as to form.

2. The Licensor gives the Licensee the consent to grant the license for the exploitation of the Work, as the case may be, to other publishers, within the scope defined in §1 above.

§4

This Licence is granted free of charge.

§5

This Agreement has been concluded for the statutory term of copyright protection, starting from the date of

signature of this Agreement.

§6

The Licensor hereby gives her consent to making changes in the format of the document in which the Work was originally produced, with no changes as to the content thereof, insofar as this may be required by the reasonable use of the Work pursuant to this Licence.

§7

The Licensor hereby gives her consent to have her personal data processed for the purposes associated with the publication of *Studia Regionalne i Lokalne* quarterly.

§8

For their validity, any amendments or modifications of this Agreement shall be made in writing, and shall have the form of an addendum.

§ 9

In matters not provided for herein, the provisions of the Act on Copyright and Related Rights and of the Polish Civil Code shall apply.

§ 10

Any disputes which might arise from or in connection with this Agreement shall be resolved by the competent courts.

§ 11

This Agreement has been drawn up in two identical copies, one for each of the Parties.
